Therefore, all concerned students are requested to complete their online registration and submit the online application in the official portal i.e. <https://bidyarthi.co.in>. **The portal is opened from 10/01/2025 till midnight of 22/01/2025.**

Following important instructions must be followed at the time of submission of online application:

- i) **The Bank Account must be in the name of the Awardee.**
- ii) Name of Account Holder should be exactly same as the name in SEBA Admit Card/Mark sheet.
- iii) The Awardee should submit the correct IFS Code (**in case of merger of Bank, new bank IFSC to be entered**).
- iv) The Bank account should be Active/ Operational.
- v) For Minor Account holder, the maximum credit limit to be maintained.
- vi) Care should be taken while entering the bank Account details (like, Numeric 0 (zero) should be entered, not alphabet "O")
- vii) Mobile number of the Awardee/ Parents must be entered for future communication.
